- Stand allocation is at the full discretion of the Organizer (see art. 6 of the General Conditions for Participation).

Note: Exhibition requirements will be taken into consideration where possible and with respect for the General Conditions for Participation in the salon and the Technical Regulations.

INFORMATION NOTICE pursuant to Article 13 of EU Regulation 2016/679 ("GDPR")

1. DATA CONTROLLER

FederUnacoma S.u.r.l., with registered office in Via Aldo Moro, 64, Bologna, in the person of its pro tempore legal representative, is the Data Controller of your personal data.

2. DEFINITION OF PERSONAL DATA AND INFORMATION RELATING TO PROCESSING ACTIVITIES

According to the GDPR, by common personal data we mean: "any information concerning an identified or identifiable natural person; a natural person who can be identified, directly or indirectly, is considered identifiable, with particular reference to an identifier such as the name, an identification number, location data, an online identifier or one or more characteristic elements of their physical, physiological, genetic, psychological, economic, cultural or social identity" (the "Data").

FederUnacoma will process the data contained in the application for pre-registration to the next edition of AGRILEVANTE, at the Fiera del Levante, in order to allow you to participate in the event.

The provision of the personal data is voluntary, however, if it is not provided, it will not be possible to process your application to the event.

3. PURPOSES OF THE PROCESSING

a. To follow up your requests

Your data will be processed by FederUnacoma to process your application for pre-registration and participation in the Agrilevante Exhibition and to manage the related contractual relationship.

b. For marketing purposes

b1. The Data Controller may process your personal data to send communications of a commercial nature and/or for promotional initiatives to offer directly its products and/or services similar to those that you subscribed to. FederUnacoma will carry out this activity in compliance with the principles of the GDPR and for the pursuit of its own legitimate interest; in any case, you may object to receiving such communications at any time by writing to the Data Controller at the email address info@federunacoma.it.

c. For the purpose of processing statistical surveys and market research

The Data Controller may process your data in aggregate form to prepare statistical surveys and complete market research. FederUnacoma will carry out this activity in compliance with the principles of the GDPR and for the pursuit of its own legitimate interest; in any case, you may oppose at any time the use of your data for the purposes described in this paragraph by writing to the Data Controller at the email address info@federunacoma.it.

4. COMMUNICATION OF THE DATA TO PERSONS LOCATED IN AND OUT OF THE EU

The Data Controller may communicate some of your data to subjects which it relies on to carrying out activities related to the organization of the event and related initiatives and/or to the publication of the multimedia contents gathered during the Exhibition.

In particular, in order to achieve the purposes described in paragraph 3 above, as an integral part of the processing, your data may be disclosed to external companies, consultants and associates, in the capacity of Data Supervisors.

The list of Data Supervisors is updated by the Data Controller and is available from the same for consultation.

In addition, the Data Controller may also communicate your data to parties that are entitled to it by virtue of legal obligations.

5. STORAGE PERIOD

The data referable to you, collected in order to allow you to participate in a specific event and/or a certain initiative or provided as part of the same will be processed throughout the duration of the event/initiative that the data collection relates to and will be stored for the applicable prescribed period following the conclusion of this event/initiative, solely for purposes related to the fulfilment of legal obligations or the defence of FederUnacoma's rights in court.

Regarding the processing for marketing purposes (direct and indirect) and for the preparation of statistical surveys and market research, the data referable to you will be processed for the duration of the contract and until there are obligations or requirements related to the execution of this contract, unless you revoke the consent you have provided.

6. YOUR RIGHTS IN YOUR CAPACITY AS DATA SUBJECT

During the period in which FederUnacoma holds or processes your personal data, you, as Data Subject, may, at any time, exercise the following rights:

- Right of access - You have the right to obtain confirmation of the existence or otherwise of data processing concerning your personal data, as well as the right to receive any information relating to such processing;
- Right to correction - You have the right to obtain the correction of your personal data in our possession if they are incomplete or inaccurate;
- Right to deletion - in certain circumstances, you have the right to obtain the deletion of your personal data in our archives;
- Right to limitation of processing - upon the occurrence of certain conditions, you have the right to obtain the limitation of processing of your personal data;
- Right to portability - you have the right to obtain the transfer of your personal data in our possession to a different Data Controller;
- Right to object - you have the right to object, at any time for reasons connected with your particular situation, to the processing of your personal data, including profiling, based on the lawfulness of the legitimate interest or the performance of a task of public interest or the exercise of public powers, unless there are legitimate reasons for the Data Controller to continue the processing that prevail over the interests, rights and freedoms of the Data Subject or for the assessment, exercise or defence of a right in court;
- Right of withdrawal of consent - you have the right to withdraw your consent to the processing of your personal data at any time, without prejudice to the lawfulness of the processing based on the consent before revocation;
- Right to lodge a complaint with the Supervisory Authority - in the event that FederUnacoma refuses to meet your requests for the exercise of the rights recognized under the GDPR, the reasons for such refusal will be given. If applicable, you have the right to lodge a complaint as described in paragraph 7 below. These requests may be addressed to FederUnacoma solely at the email address info@federunacoma.it.

7. COMPLAINTS

If you wish to lodge a complaint regarding the manner in which your data are processed by FederUnacoma, or with regard to the management of a complaint you have submitted, you have the right to file an application directly with the Supervisory Authority.
