#### DISCLOSURE pursuant to Article 13, Regulation (EU) 2016/679 ("GDPR")

The Data Controller is FederUnacoma S.u.r.l., with registered office in Via Aldo Moro, 64, Torre I, Bologna, in the person of its legal representative pro tempore, who can be contacted at the email address [privacy@federunacoma.it](mailto:privacy@federunacoma.it).

The Data Controller processes the data requested and provided by you (name and surname of the parent/guardian and of the child) in accordance with the principles of correctness, lawfulness and transparency.

The data provided will be used exclusively for the purposes strictly connected with and instrumental to the "assumption of responsibility for the minor" so as to allow the minor aged 14 to participate in the Agrilevante 2023 event.

The provision of the personal data indicated is voluntary but necessary in order to allow the minor under the age of 14 to participate in the event (legal basis art. 6.1.f GDPR legitimate interest: Guarantee of the Organiser). The data may possibly be processed to fulfil legal obligations (legal basis art. 6.1.c GDPR legal obligation) or the protection of a right of the Data Controller itself (legal basis art. 6.1.f GDPR legitimate interest: protection of a right).

The processing of the data provided will be carried out in automated and/or manual form, in compliance with the provisions of Article 32 of GDPR 2016/679, by specially appointed persons such as employees and associates of FederUnacoma S.u.r.l. and in compliance with the provisions of Articles 28 and 29 GDPR 2016/ 679 (the list of Data Processors is available from the Data Controller for consultation). In addition, the Data Controller may communicate your Data to the subjects to whom the communication is due by virtue of legal obligations. Data will not be transferred outside the European Union.

The data will be kept for a period of time not exceeding the achievement of the purposes for which they are processed and in any case in compliance with the prescriptive term provided by law. At any time, you may exercise your rights pursuant to Articles 15 - 22 of the European Regulation (EU) 2016/679 (GDPR) or lodge a complaint with the Data Protection Authority.
